

# BOROUGH BASED JAILS PROGRAM NOTICE OF INTENT

August 2021

Actual or Planned

The New York City (City) Department of Design and Construction (DDC) intends to issue a single request for qualifications (RFQ) from design-build teams with experience in the design and construction of detention facilities or similarly complex high-rise building projects exceeding 500,000 s.f. who are interested in providing similar services for the new Facilities in the NYC Borough-Based Jails Program (Program). Based on industry feedback, the City is modifying the lump sum contract delivery format adopted previously for the Early Works to a **Cost Plus Not-to-Exceed Guaranteed Maximum Price (GMP) format** in accordance with the New York City Public Works Investment Act. This GMP procurement approach will allow for a "target price proposal" to be submitted at the RFP stage and for a "contract price proposal" to be developed collaboratively with DDC and the awarded Design-Builder during the Phase 1 Design and Enabling Work under the Design-Build Contract. At the conclusion of Phase 1, the Phase 2 Design-Build completion work will be authorized. This Notice of Intent (NOI) is being issued solely for informational and planning purposes and does not constitute a solicitation. DDC is not seeking responses to this NOI.

# Background

Passed by the City Council in October 2019, the City's plan to close the jails on Rikers Island and build smaller, safer and fairer borough-based jail facilities comes at a time when New York City has the lowest crime and incarceration rates of any large city in the United States. This is part of a once-in-many-generations opportunity to build a smaller and more humane justice system that includes four facilities grounded in dignity and respect offering better connections to the Court system. The Facilities will be designed to accommodate the needs of families as well as for medical, mental health, education, and therapeutic programming service providers.

In selecting the design-build teams and carrying out a collaborative design-build approach to project delivery, DDC is committed to using industry best practices. DDC will utilize a best-value selection process that prioritizes design, quality, past performance, and qualifications. DDC will make available stipends to short-listed firms that participate in the Request for Proposal (RFP) process but are not selected to be awarded a design-build contract.

### Program to date

## Early Works:

DDC has initiated procurements for designbuild services for early works packages at each of the sites as set forth in the adjacent table. The Queens site also includes a new garage and community center. The other site packages have contract budgets ranging from \$43.6 to \$136.8 million.

The budget for each facility is \$1.5 to \$1.8 billion.
